## Terms of Membership

1. Dues may be paid annually or monthly by automatic checking withdrawal.
2. Payments are due on the first day of each month. There will be a penalty fee for any dues payments that is received after the 15<sup>th</sup> of the month or any checks returned due to insufficient funds.
3. Samena Club shall have the right to deny admittance to the club to any member whose dues are more than 30 days past due until their account is brought current.
4. If at anytime member's account is delinquent 2 months or more the Samena Club reserved the right to terminate the membership and initiate collections proceeding for the entire amount of the contract and/or any amounts due. Non-use of the facility does NOT constitute a dropped membership or relieve the member of the responsibility for accumulating dues.
5. Termination of Membership: Once membership at the Samena Club is established for one year, a member's legal responsibility for dues shall be continued until such time that that Samena Club receives a **signed/dated membership termination form, membership cards and payment of any outstanding balance**. Until that date members remain legally responsible for all dues. **30 day advanced notice** is required for all termination notice. Termination notice must be delivered **in person** or by **certified mail**.
6. All Member, with the exception of Certificate Members, shall be considered in good standing so long as the following conditions are met:
  - ◆ The member does not owe any dues or other charges over forty –five (45) days past due
  - ◆ The member is not under suspension for disciplinary reasons
7. Members who drop their membership or whose memberships are terminated for non-payment may reactivate their membership by payment of all unpaid dues and charges due at the time of termination in addition to the intervening monthly dues up to a maximum of nine (9) months. Reactivation by payment of a new initiation fee is permitted only after two (2) years of inactive status.
8. If a member wishes to cancel this agreement without penalty they may do so by delivering or mailing a written notice, stating that they do not wish to be bound by this agreement. This notice must be delivered or mailed before midnight of the third business day after this agreement is signed.
9. Member agree to abide Club Rules and Regulations and the Code of Conduct and agree that all persons using the Club under this membership are bound by and shall comply with the rules and regulations of the Club as they may be amended from time to time.

## Membership Types & Definition

**Individual:** An Individual Membership consists of one person. A spouse and children are not entitled to the rights and privileges of this category of membership, but may be guests in accordance with the Club's rules and regulations by paying the prevailing Club guest fee per Club use.

**Family:** A family membership consists of all members of a family that reside in the same household on a permanent basis and are currently declared to the Internal Revenue Service as dependants of the person(s) holding the membership.

**Senior:** A senior citizen membership consists of a person or couple, one of whom has reached the age of 62. Member must notify upon qualification.

**Program:** A program membership consists of a child participating in designated program for a specific length of time.
